**RE: Support of the *Resident Physician Shortage Reduction Act (S.2439/H.R.4731)***

Dear Sens. Boozman, Warnock, Collins, and Schumer, and Reps. Sewell and Fitzpatrick:

As the Alliance of Specialty Medicine (Alliance), our mission is to advocate for sound federal health care policy that fosters patient access to the highest quality specialty care. As patient and physician advocates, the Alliance writes in support of your legislation, the ***Resident Physician Shortage Reduction Act (S.2439/H.R.4731)***, which would increase the number of Graduate Medical Education (GME) residency positions an additional 2,000 residency positions each year for seven years to tackle the severe physician manpower shortage.

We thank Congress for taking steps to begin to address this issue by approving 1,200 new Medicare-supported GME slots in the *Consolidated Appropriations Act, 2021 (P.L. 116-260)* and the *Consolidated Appropriations Act, 2023 (P.L. 117-73)*. However, according to the Association

of American Medical Colleges (AAMC), the United States will face a shortage of up to 124,000 physicians by 2034. While the Alliance acknowledges the need to increase the number of available primary care providers, we note that specialty shortages will be particularly large, including neurosurgeons, urologists, rheumatologists, ophthalmologists, cardiologists, gastroenterologists, plastic and reconstructive surgeons, dermatologic surgeons, osteopathic surgeons, and general surgeons. Given the increased demand created for their services by an aging population and expanded insurance coverage, we need to take steps now to ensure a fully trained specialty physician workforce for the future. Your legislation will begin to improve the acute shortage of specialty physicians.

The Alliance recognizes that both primary care providers and specialists are an integral part of American medicine. Your legislation would improve the nation's graduate medical education system and help to preserve access to essential health services for many Americans. For these reasons, the Alliance extends our strong support for your legislation.
